SHARE Celebrates Reaching 4,000th Client Milestone with A Look Back at First Client Linda Texceira's Inspiring Story

IN ITS 45-YEAR HISTORY, SHARE has made countless phone calls to clients in need — fielding requests for help, exploring adaptive technology solutions with users, and lending ongoing support to an ever-growing client community that just reached 4,000 children and adults.

SHARE's legacy of service began with a single call to a young woman in Little Compton, Rhode Island, back in 1981. The goodness and hope sparked by that one conversation continues to ripple, changing lives to this day. Linda Texceira — SHARE's first client — has had a front-row seat to SHARE's enduring impact and remembers where it all began.

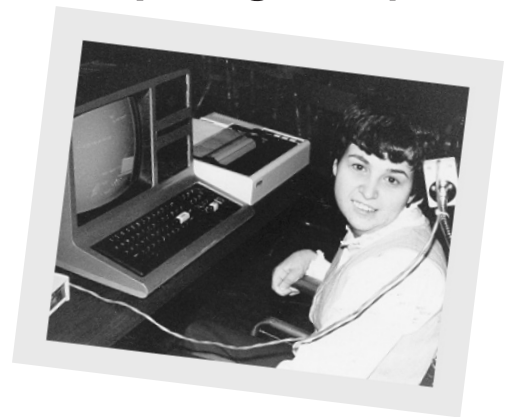
When Linda Texceira was born in 1958, having cerebral palsy limited



not only her range of physical abilities, but her options to engage with the world around her as well.

"Throughout my life, having cerebral palsy and not being able to communicate made me wonder how I could ever be able to let anyone know what I needed or what I wanted," said Texceira.

In those years, public schools had not yet developed inclusive classrooms or individualized education plans, so Linda's parents, Martha and Al Texceira, took matters into their own hands, quite literally. Al designed a custom plexiglass eyeboard featuring the letters of the alphabet in neat rows. Once Martha taught Linda the alphabet and how to spell words, Linda was able to communicate by shifting her gaze from letter to letter to spell out words

and sentences to the person watching the shift of her eyes from the opposite side of the board.

"Before I began working with SHARE, the only way I could make my needs and desires known was by looking at a plexiglass board with the alphabet written on it," recalled Texceira. "My mother or someone would read each letter and spell what I wanted to say."

In the spring of 1981, Fall River's *Herald News* ran a feature story about Linda and her custom eyeboard communication device. Les Cory, a computer engineering professor at UMass Dartmouth, read the article and thought that computer technology held the potential to offer Linda a better solution.

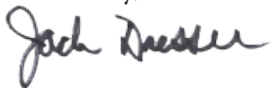

We expect the program will strengthen local workforce pathways into rehabilitation and assistive technology and continue SHARE's long tradition of turning student energy and classroom learning into real-world impact.

SHARE Client Linda Texceira's Inspiring Story

"I get a call from a special person — Les Cory," said Texceira. "He says he saw an article in the newspaper about me talking using an eyeboard. He wanted to meet me and give me a way to communicate independently."

That summer, Cory and fellow UMass Dartmouth engineering professor Phil Viall designed a custom computer system that enabled Linda to write sentences, use a telephone, and "speak" with an electronic voice synthesizer — all by operating a single switch. Looking back to that first phone call from Les and the futuristic technology he was proposing, Linda says she couldn't have imagined the seismic impact this adaptive technology would have on her and her family.

"I thought I was dreaming when I heard that!" said Texceira. "It was not a dream — I could talk for the first time in my life."

News of Linda's life-changing computer system spread quickly, sparking a flurry of requests for help from others living with similar physical and neurological challenges. To better meet the demand for adaptive technologies and streamline service delivery, Cory, Viall and university colleague Professor Rick Walder formed the Society for Human Advancement through Rehabilitation Engineering Foundation, Inc. (SHARE Foundation) in 1982. The nonprofit began working with its 4,000th client this spring.

In the decades since first working with Linda, SHARE has kept pace with her changing needs and regularly pairs her with new or updated adaptive technologies. Linda's current system is controlled simply by moving her eyes and gazing at points on her laptop monitor. A camera detects where she is looking and uses that information to emulate a mouse and keyboard,

allowing Linda to string messages together one letter at a time. The system's word prediction software learns the typical word usage of the user and is able to suggest a variety of possible next words in a given sentence; if the desired word is seen, Linda can gaze at that word to select it. Frequently used phrases and sentences (e.g., "I'm hungry" or "Let's go outside") can be saved for future use. Words and phrases also can be spoken through the computer's built-in speech synthesizer.

"It's kind of a throwback to her original eyeboard," said Viall, "except there is a camera that detects where she is looking, instead of Linda's mother or another person."

When Linda is using software such as Word, Excel, Google Chrome, and email, the system allows her to direct mouse movement using eye tracking. When Linda's gaze is fixed for a few seconds on a particular point on the laptop screen, a special mouse menu pops up with options such as click, double-click, right-click, or click-and-drag. The entire system is battery-powered and can be mounted to Linda's wheelchair, allowing her ease of communication whether she is at home or on the road.

Linda's adaptive technologies have helped her give voice to dreams that she once thought impossible. With determination, hard work and strong family support, Linda reached her goal of earning her high school diploma in 1991. When that day finally arrived, one long-time SHARE supporter didn't miss the chance to cheer her milestone moment. "At my graduation, Les came," remembered Texceira.

Looking back, Linda has been humbled to watch, year after year, as SHARE turns technology into transformation for so many.

"My life was changed," said Texceira, "and I thank God every day for the gift of Les caring to help me — to help little old *me* — and 4,000 other people."

Charitable Giving Impacted by Tax Law Changes

Starting in the 2026 tax year, new tax law changes have reshaped the tax benefits of charitable giving — and donors to the SHARE Foundation may want to consider adjusting their giving strategies.

Non-itemizers now can take their standard deduction and add to that a deduction for itemized contributions totaling up to \$1,000 for single filers and \$2,000 for those who file jointly. For itemizers, the law introduced a new floor: only donations exceeding .5% of adjusted gross income count for deduction, and total itemized deductions face tighter caps.

These changes make planning more important — small donors benefit immediately, while higher income donors should evaluate gift timing to preserve tax efficiency.

One tax-wise strategy was unaffected by the changes. If you are over age 70½, consider using qualified charitable distributions from your IRA for your giving. These distributions count toward your Required Minimum Distribution (RMD), while reducing your overall taxable income.

PC scams are common. Stay skeptical of unsolicited contacts, protect remote access, and never call support numbers shown in browser pop-ups.

Ignore unsolicited pop-ups and calls.

Legitimate companies (for example, Bank of America, Amazon, Microsoft) will not call or pop up in your browser out of the blue to warn you about a virus or demand payment.

Never grant remote access.

Scammers often ask you to run commands, download software, or allow remote control tools so they can “fix” a problem. Don’t give anyone remote access to your computer unless you initiated the contact and can verify the technician’s identity.

Never pay with gift cards or cryptocurrency.

Real tech support will not demand payment via gift cards or crypto. If someone asks for these payment methods, it’s a scam.

Keep security software updated.

Use the built-in protections (Windows Security) or a reputable third-party antivirus, and keep them up to date. Note that security software sometimes won’t block deceptive browser pop-ups, so remain cautious.

Manage credentials. Use unique, complex passwords for each account and consider a reputable password manager. Always enable multi-factor authentication (MFA) where available.

If you’re unsure whether a support contact is legitimate, contact the company using a verified phone number or support page — not the number or link provided in the pop-up or unsolicited message. Any legitimate company will welcome a call to verify the authenticity of a transaction.
